

Biante Model Cars 1:10 Scale Model Giveaway Terms and Conditions

1. Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.
 2. Entry is open only to Australian residents except directors, management and employees (and the immediate families of directors, management and employees) of Biante Model Cars, the "**Promoter**" ABN 51 067 134 409.
 3. The competition begins at 12:00 Midday (AWST) on Friday 18/11/2011 and closes at 12:00 Midday (AWST) on Friday 20/01/2012. i.e. "**Competition Period**"
 4. To enter, entrants must, during the Competition Period:
 - (a) Visit www.biante.com.au and make a minimum purchase of \$250.00AUD or higher in one transaction;
 - (b) On receipt of payment, the entrant will be automatically placed into the draw.
- Entrants are responsible for their own costs associated with accessing the Internet.
